TERMS AND CONDITIONS

1. All Maintenance Fees **must** be in good standing, prior to an Owners' Lodge being accepted on our Resale Program.
2. The owner is required to provide Hilton Grand Vacations with the Registered Holiday Certificate prior to the Lodge being accepted on our Resale program. If the owner is not in possession of this Certificate then an Indemnity Form must be completed. (This form can be obtained from Hilton Grand Vacations.)
3. The Lodge cannot be put up for rental or exchange purposes while up for resale as this could infringe on any sale in progress. If the owner is attempting to sell the lodge privately in addition to through Hilton Grand Vacations, then the Hilton Grand Vacations sale will take priority over the private arrangement. An owner can check at any time to find out if the lodge has been sold, by telephoning Hilton Grand Vacations Sales Office on 013397 53454.
4. Hilton Grand Vacations Resale Office will contact the owner as soon as a sale is initiated firstly by telephone, and followed by letter advising that we have accepted an offer on behalf of the owner. A verbal acceptance from the owner is acceptable in order for the sale to proceed.
5. The purchaser has the right to cancel the transaction up to 14 days from signing the initial agreement.
6. At the conclusion of the Resale Procedure the original certificate will be made null, a new certificate will be issued to the New Owner. A statement will be sent to the original owner from Hilton Grand Vacations.
